

INDICATIONS: Collanol contributes to the normal functioning of the locomotor system, helps to maintain the normal condition of bones, joints and cartilage.

ACTION: The two patented active ingredients of Collanol – undenatured type II collagen (UC-II®) and micelle curcuma extract (NovaSOL®) – are synergistically active in favor of the active recovery of normal joint, tendon and cartilage conditions, and help to improve mobility.

Five main types of collagen are known in medicine, with only one of them is responsible for joints, tendons and cartilage – that is collagen type II. Undenatured type II collagen, contained in Collanol, is derived from chicken cartilage through a patented low-temperature manufacturing process, in which the natural three-dimensional collagen spiral remains intact. Thanks to this triple spiral, when reaching the small intestine, undenatured type II collagen causes an immune response called oral tolerance. Special immune cells (Treg) are triggered, which have the ability to retain the process of degradation of the articular cartilage and, with prolonged action, to turn it towards the reactivation of the natural collagen synthesis process in the human body. As a result, self-recovery and re-construction of cartilage tissues is stimulated.

Due to its unique mechanism of action, UC-II® with undenatured type II collagen has high efficacy at low doses – just 40 mg per day (the content of 1 Collanol capsule).

The effectiveness of Collanol is additionally enhanced by the incorporation of the highly concentrated micelle extract of curcuma NovaSOL®, a rich source of curcumin. Curcumin has a powerful antioxidant potential. It has been clinically proven that thanks to patented solubilizing technology and its micelle formula, curcumin incorporated in Collanol achieves 185 times higher bioavailability compared to regular curcuma extract. This also determines its high efficacy at low doses. Laboratory tests show that 500 mg of micelle curcumin is equivalent to approximately 5000 mg of natural raw curcumin powder. Thanks to the antioxidant properties of curcumin and its ability to cleanse the body from nitric oxide, Collanol contributes to a slower pace of cell aging processes and to maintaining the health and activity of:

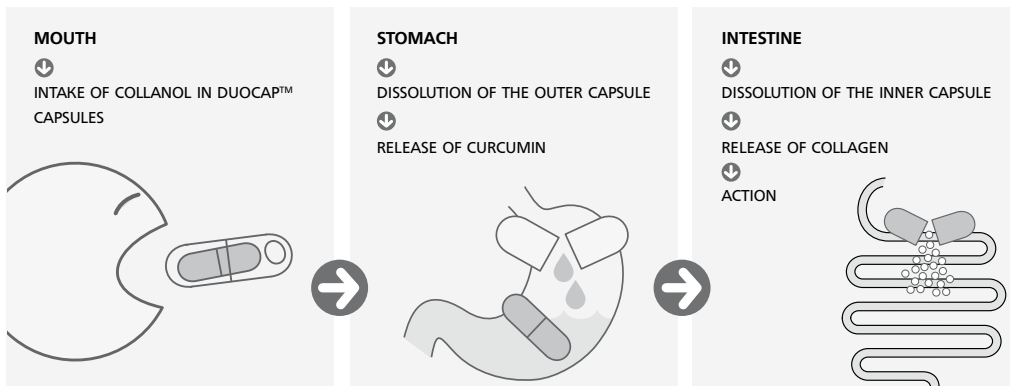
